To this vision, one of their signature programs is S.E.A.L, designed to close the achievement gap of English language learners by third grade through enriched academic language instruction in both Spanish and English. That commitment to the needs of Spanish-speaking communities led Sheri to sponsor RTC’s first Spanish-language CBA class.

“My family’s foundation has taught me the importance of addressing the needs of the Spanish-speaking communities to create rich and vibrant local communities in which everyone can contribute, regardless of their native language,” Brisson said. “Offering future entrepreneurs training and coaching in their native tongue allows RTC to reach a large group of individuals who can then build economic stability for themselves, their families, and their communities.”
